CHANGING OF THE GUARD

The year 2000 marks the twentieth anniversary of the founding of the Nail-Ray Association. Three of our long-term officers chose this occasion to officially step down from their posts: Richard Weakley, who has served as Treasurer since 1994; Dorothy Plymate, who has served as Corresponding Secretary since 1981; and Charles E. Nail, who has served as our President since 1986. As a token of our appreciation for their many years of dedication and hard work, the association presented each of these retiring officers a personalized gift: an engraved letter opener for Dick, a Shelby County coverlet (with her name embroidered onto it by her daughter-in-law) for Dorothy, and an engraved rosewood clock for Chuck.







At the presentation on Sunday afternoon, incoming President Tom Plymate commented that he thought the gift for Chuck was especially appropriate because it was in the shape of a book. One of the things that has set our Nail-Ray Association apart from so many other family history organizations is the quantity and quality of the books we have produced. Not only did Chuck take the lead in compiling our "<u>Where They Are Now</u>" book on the gravesites of the first three generations of Nails and Rays, he also presided over the organization throughout the conception and production of our "<u>Nail-Ray Family Photo</u> <u>Tree</u>", our "<u>Nail-Ray Family Stories</u>", and our BIG BOOK, "<u>The Families of Henry Nail & Mary Keller and Thomas Ray & Elizabeth Pearce: Pioneers of Shelby County, Indiana, Second edition</u>". Chuck's continual encouragement, exhortations, and even badgering, contributed significantly to the timely completion of each of these fine books.

Although Dick, Dorothy, and Chuck will be officially stepping down from their offices, we look forward to them remaining active, contributing members of our organization for many years to come.

BUSINESS MEETING

The business meeting was held on Saturday morning at the Shelbyville Super 8 Motel. President Charles E. Nail called the meeting to order with 37 members in attendance. After Chaplain James Russell opened the meeting with a prayer, President Nail reminisced about the organization's first twenty years, with special recognition of the contributions of Julia Sherer and her mother Myrtle Smith whom he credited with bringing this group together and Dorothy Plymate whom he credited for holding us together for two decades by keeping us in constant communication and by providing the "home base" for our annual reunion. He then noted the "new faces" who have recently become interested in our association, and he predicted that our organization can look forward to a wonderful future.

President Nail made special note of a letter recently received from a William C. Ray from Virginia. This letter included new information about three of the seven early Ray families in Wake County, North Carolina, including information about William Ray Sr., William Ray, Jr. (both of whom lived in Brunswick County, VA, before moving to Wake County) and Nathan Ray. Chuck challenged us to continue looking into this new lead on the ancestry of our patriarch, Thomas Ray.

The minutes from the 1999 meeting were read by Lynda Plymate, substituting for Dori Dvorak. Dori was unable to attend this year because she was home taking care of the newest Nail-Ray member, Benjamin Thomas Dvorak, born on May 27, 2000. Benjamin is a tenth-generation descendant of Thomas Ray and Elizabeth (Pearce) Ray.

The next topic of discussion was Old Union, our ancestral church, which is currently undergoing financial stress because of declining attendance. James Russell spoke eloquently about the importance of Old Union to our organization. Members of the association were asked whether they wanted to donate money to the church to help keep it open. Dick Weakley moved that we donate \$1000 from the Nail-Ray treasury to Old Union. Lolita Guthrie seconded the motion and it passed unanimously. Clarene Russell moved that this donation be made "in the name of the Nail-Ray Association and in honor of Dorothy Plymate." Rebecca Markel seconded the motion and it passed unanimously.

Terry Keller, chair of the Nominating Committee, presented the following slate of officers for 2000-2002, and they were elected by acclamation:

"IT'S IN THE LIBRARY"

Tom Plymate led a discussion of how we should distribute the remaining copies of "THE BIG BOOK", our 1997 <u>The Families of Henry Nail & Mary Keller and Thomas Ray</u> <u>& Elizabeth Pearce: Pioneers of Shelby County, Indiana, 2nd edition</u>. He reported that 171 of the 203 copies received from the printer had been distributed, leaving a remaining stock of 32 copies. The group agreed that we should hold some copies in reserve for sale to individuals who find out about our organization by word-of-mouth in future years, but the consensus seemed to be that 32 copies was more than enough to meet the demand expected from that source. We therefore discussed whether we should be more aggressively trying to "drum up" additional interest in THE BIG BOOK by purchasing advertisements in genealogical publications, or whether we should try to place some of our "excess" copies in additional libraries. The group decided that the latter seemed more appropriate.

Tom distributed a list of the 27 libraries currently having copies of THE BIG BOOK, and another list of libraries that had been suggested as places where our book might be

appreciated. After extensive discussion, individual members volunteered to purchase copies to donate to seven of the libraries on the second list, and the organization voted to place copies in an additional six libraries at the organization's expense. After these placements have been completed, THE BIG BOOK will be available to the public in a total of 38 libraries, including 6 in Indiana, 6 in Illinois, 4 in North Carolina, 4 in the Washington DC area, 3 in Virginia, 3 in Iowa, 2 in each of Missouri, Tennessee, and Texas, and 1 in each of Colorado, Georgia, Mississippi, New York, Utah, and Wisconsin.

NEW PROJECTS

Terry Keller and Chuck Nail reported that they have started work on a video which will summarize the history of the Nails and Rays. They invited us to view what they had taped so far at Dorothy Plymate's home later that afternoon. They requested that each branch of the family record their own video "snippets" of the homesteads and land-grant sites of their ancestors, with narration by family descendants. They requested that we send our video snippets, along with relevant still photos and documentation to Terry, and his daughter will then edit and compile them into a consistent format.

Clarene Russell asked us to consider placing historical markers on Nail-Ray lands. She asked President Nail to form a small task force to determine how this is done in Indiana and to report options for us to consider at our next meeting.

OTHER FESTIVITIES

31 of us enjoyed the food, music, and frivolity at the newly redecorated Boggstown Cabaret on Friday evening. Many members considered Charlie Ketron's rendition of "Baby Face" to rival some of Terry Keller's finer performances from years past.

41 of us gathered for dinner at the Goodrich Party House on Saturday evening, where our cousins Cora Marie and Julia Lavina stuffed us to the gills with their wonderful home cooked fried chicken, roast beef, green beans, corn, mashed potatoes, noodles, rolls and pie!

38 attended Sunday worship service at Old Union United Methodist Church. Piano music was furnished by Lynda Plymate of Springfield, Missouri. Pastor Larry Odom was assisted by Nail-Ray Chaplain James M. Russell of Collierville, Tennessee.

48 attended the pitch-in dinner in the church basement Sunday afternoon, served by Virginia Fisher, Thelma Merry, and "Smiley" and Wilma Rutherford. At the Sunday afternoon program, Shelby County Historian David Craig entertained us with a story about "Shelby County's Unsolved Murder."

I'd like to extend my gratitude to them for their personal efforts of recording examples of our heritage as proclaimed by membership in the Nail-Ray Association, and further their sharing of the above mentioned photographs with me. . . The drawing of the Heistand/Ballard farmhouse was done from a photograph taken by my Aunt Nancy (Ballard) Bogardus. She had written across the photograph, "The house on Ma's farm." This was sent to me by my cousin, Dr. Carl Bogardus."
